

#### Partnership

SIHFW has partnered with development agencies as UNICEF and UNFPA to roll out the RMNCH+A initiative launched by MOHFW as well as with FSSAI to build capacities in the field of Food Safety.

#### SIHFW – UNICEF partnership

The partnership with UNICEF is dedicated to improve the child health in Rajasthan. It focused on strengthening of cold chain management to support the immunization program in Rajasthan.

Support to digitalization of health survey has been provided under this partnership to get an elaborated health data which would ease in tracking and analyzing health related issues among the population and geographical areas.

This partnership has long been involved in the onsite mentoring of the health staff in Barmer and Dungarpur. The theme based mentoring first trains the trainers in the specific theme who in turn mentors the health staff at their place of posting thus saving time and making it conducive to adapt the newly acquired/ updated knowledge and skill.

Under the partnership the frontline functionaries were given the refresher BRIDGE (Boosting Routine Immunization Demand Generation) course to develop capacities to leverage Social and Behavioral Change Communication for Routine Immunization. The purpose was to boost the Inter-personal communication for Routine Immunization.

The book 'Public Health in Rajasthan: Perspectives, Issues and Challenges' developed in the previous year with the support of this partnership was printed in this year.

#### SIHFW-UNFPA partnership



Through the Annual Work Plan, a large number of focused activities are planned for the year with specific expected outcomes. In this year, the partnership focused on building capacities of the stakeholders viz. store keepers of FW store and DNOs for Family Planning – Logistics Management Information System (FP-LMIS), a software developed for maintaining the contraceptive logistics. Similarly, orientation of service providers on strengthening quality assurance in family planning was conducted in 21 districts of Rajasthan, of which 19 were non-MPV districts. Training of faculties of pre-service education institutes – ANMTCs/ GNMTCs on Injectables was done under the AWP.

Along with this, mentoring of the roll out of FP-LMIS to improve environment for FP services in selected eight districts of Rajasthan (Alwar; Bharatpur; Chittorgarh; Jaisalamer; Pali; Rajsamand; Sawai Madhopur; Udaipur) was done.

Another key area, in which the partnership worked was printing of material for generating awareness and enhancing knowledge such as ANM brochure for ANMs on FP-LMIS; Maternal Health protocols and checklist posters for screening of clients for Antara injectable and PPIUCD.

Besides these, technical and financial support for updating the software 'Umang' for the ANMTCs and GNMTCs of Rajasthan and workshop on Job Responsibility was extended through this AWP.

#### **Training Partnership with FSSAI**

SIHFW has become the training partner of the training wing of FSSAI – FoSTaC. Under it two trainings have been done – Training of Trainers for Street Food Vendors and Training of Trainers for Catering Services.

#### **Research and Consultancy**

SIHFW, Rajasthan has consistently been trusted and endowed with the responsibility of recruitment of various cadres for health sector. This year, SIHFW has been approached by RSACS for recruitment of various positions. The procedure is under process.
